DECLARE

To be aware of the risks, whether predictable or unpredictable, associated with the practice of kart racing, despite not being considered a potentially dangerous activity. We assume all liability of a sporting, civil and criminal nature, and unreservedly accept the EasyTraining Regulations.

We also undertake to:

1. ensure that the child has reached the age of 6 years;
2. be in possession of a medical certificate demonstrating the child's suitability to perform non-competitive sports;
3. wear clothing (suit, gloves, shoes, helmet) in accordance with National Kart Regulations;
4. use a kart which complies with the Technical Regulations, and to not have tampered with in any way;
5. unreservedly agree to use only the engine supplied by the Promoter for the duration of the event, as assigned by way of a draw, to have not tampered with it in any way, and to return it in the same condition in which it was received. Moreover, given the mechanical components, we renounce any compensation or dispute in the event of any operational defects;
6. use exclusively the fuel supplied by the Promoter;
7. have checked that the minimum weight of kart + driver, in running order and in the condition in which it crosses the finish line, will not be less than 70 kg as required by the Technical Regulations;
8. agree to allow the kart used to undergo the compliance checks set out by the Promoter in coordination with the Sports Authority at any time during the event;
9. I have read carefully and assessed the contents of this document, and have clearly understood the meaning of each point before signing. I have understood and agree entirely with these regulations laid down for the safety of the child, that non-compliance with them may put both the child and the other programme participants in danger. Pursuant to Articles 1341 and 1342 of the Italian Civil Code, I hereby expressly approve all points of this document.

WARNING: please note that third party liability insurance and the organiser's insurance shall take effect only if the kart is entirely original in each of its components. The Promoter reserves the right not to admit karts to the events which do not comply with the original product.
