DECLARES UNDER HIS OWN RESPONSIBILITY

1. to have seen the current condition of the track, the equipment and technical support in the circuit, including the safety measures applied, as well as the condition of the kart and the vehicles, if provided by A.S.D. Trentina Karting, that they are suitable for the activity to be carried out and to have verified the perfect condition and compliance with their requirements, and therefore, for himself, his heirs and successors in all capacity and regard, A.S.D. Trentina Karting, the circuit and the Municipality of Ala as the owner, to liberate and exclude from all consequences arising from the activity, including accidents and/or damages caused by the condition of the track, equipment, services and machines of the circuit;
2. to be in perfect physical and mental health, not to use substances (alcohol, drugs, medicine, etc.) which in any way may impair or alter performance and to be in possession of a valid medical certificate certifying his physical and mental aptitude, and thus to release A.S.D. Trentina Karting, the companies and staff it claims in carrying out its activities, the circuit and the municipality of Ala from any responsibility for physical problems that may occur during physical activity;
3. to be fully aware that the application for access permit only concerns the right to use the track and/or the kart and/or the motorcycle and/or other motor vehicles throughout the test period, and not exclusively but simultaneously with other users and categories, without the A.S.D. Trentina Karting having an obligation to illuminate the circuit or to provide flags, medical services and fire protection services, which thus may not be arranged and active;
4. undertake not to allow any other person to drive in the circuit with the above-mentioned vehicle, taking on all responsibilities and sanctions, civil, administrative or criminal prosecutions resulting from non-compliance with this rule;
5. to be fully aware, after careful consideration, of the "General Regulation of the Karting Circuit, Ala Karting Circuit" that apply on the track and in the whole facility during the tests and undertake to comply fully with the aforementioned Regulation, as well as any additional provisions that may be made during the tests by A.S.D. Trentina Karting, employees and/or persons responsible, by track personnel and track commissioners, in particular with regard to the rules and instructions set forth in the Regulation;
6. assume full responsibility and liability for damages, damage to property and/or financial loss to the undersigned himself, to the A.S.D. Trentina Karting, the circuit and the municipality of Ala or third parties that have been inflicted as the result of non-compliance of the undersigned himself and/or his assistants and companions to the rules of ordinary care and caution, the regulation and/or the provisions set out in point 5 and, in any event, consequently, as a result of any conduct which he has committed inside and outside the Facility, thus exempting the A.S.D. Trentina Karting, the circuit and the Municipality of Ala from any responsibility in this context;
7. to be fully aware of and expressly accepting the risks associated with the exercise of motorsport, including with regard to and knowledge of the simultaneous presence of other drivers on the track, to accept them consciously and with this awareness of wanting to carry out motorsport activities in the sports facility, by express declaration, in other words, and as much as it is necessary to give his express consent to the performance of this activity, which takes place under the full and exclusive responsibility of his/her own, and also in the event that he/she is free of experience and/or specific knowledge of the "Kartodromo Ala" route, and declares himself in perfect health and in possession of the legally valid and effective driving licence, as well as the personal and technical skills for the driving of the vehicle;
8. to exempt and exclude the A.S.D. Trentina Karting, the circuit and the municipality of Ala of any responsibility and liability for all physical damage, property damage and/or financial loss which may be inflicted on the undersigned himself, his assistants and accompanying persons or the vehicle conducted by the undersigned (even if in the possession of third parties and, in this case, to exempt and exclude the A.S.D. Trentina Karting, the Kartodromo, the municipality of Ala, from any resulting liability and responsibility towards the third party owner) that may arise from the practice of the abovementioned activity;
9. also to exempt and exclude A.S.D. Trentina Karting, the circuit and the municipality of Ala from any responsibility and liability for all physical damage, damage to property and/or financial loss inflicted by third parties on the undersigned himself, his assistants and companions or the vehicle conducted by the undersigned person;



10. to protect and indemnify the A.S.D. Trentina Karting, the circuit and the Municipality of Ala from any claims of third parties in any capacity which is due to or may only be related to the behaviour of the undersigned inside and outside the racetrack, and also undertake to compensate the aforementioned for any expenses and damages caused by the above activity to the circuit, the facility and the vehicle possibly provided;
11. to understand and accept that in the event of an accident, the A.S.D. Trentina Karting, the Kartodrom, the municipality of Ala, but without any obligation or responsibility with regard to the timeliness of the intervention, suspend traffic on the track to order for continuation, remove all obstacles which could prevent the normal conduct of the tests, without, however, guaranteeing the continuation of the tests themselves, and to be aware that the collision between vehicles is governed by the law, with the exemption by the aforementioned disclaims of responsibility and liability;
12. ensure that to the proceedings on the track is given the greatest attention also if identifying obstacles, which are reported to the other drivers and the management of the circuit;
13. that the vehicle conducted by the undersigned is in soundness and perfect condition for the tests to be carried out and that the undersigned himself has impeccable psycho-physical capacity to conduct the mentioned vehicle and undertake to wear appropriate safety clothing and protective devices with valid homologation in order to be able to carry out the tests safely and flawlessly, and that these conditions are maintained and guaranteed throughout the testing;
14. to be aware that A.S.D. Trentina Karting can use the existing equipment of the facility to carry out video recordings and images of the track and the non-track area, and expressly authorizes them to be able to be carried out and stored for safety reasons and that they are not available to the driver or can be claimed by the driver, but, if any, are made available to the public authorities only in legal cases and that they can be used as evidence by A.S.D. Trentina Karting, the circuit and the municipality of Ala;
15. to authorize the publication of images and/or videos showing the undersigned, his assistants and companions and/or the conducted vehicle by A.S.D. Trentina Karting, on the website "www.alakarting.it" and on social channels (WhatsApp®, Facebook®, Instagram®) for advertising or marketing purposes in connection with the activity of A.S.D. Trentina Karting, without prejudice to the prohibition of use in abusive or dignity damaging context. The use of images as a whole is free of charge and cannot file a claim;
16. to acknowledge and accept that A.S.D. Trentina Karting, the circuit and the Municipality of Ala are not responsible for the theft and/or damage of goods and vehicles introduced and carried into the facility, knowing full well that the parking spaces, including those located outside the circuit, are unattended;
17. to accept, without exceptions and/or claims for damages, that A.S.D. Trentina Karting may, if necessary and/or in its own unchallengeable judgment, modify, suppress or interrupt the use of the track and its facilities during the tests;
18. this disclaimer statement and all obligations and/or commitments contained therein are governed exclusively by Italian law. All claims relating directly to the use and/or even only in connection with the use of the entire facility, the exercise of the test activity and the interpretation, execution, validity or effectiveness of this act shall be transferred to the exclusive Italian jurisdiction and, in this context, shall be the exclusive jurisdiction of the court of Trento.
19. **TRANSITIONAL PROVISIONS IMPOSED BY THE COVID-19 HEALTH EMERGENCY - VALID UNTIL WRITTEN AMENDMENT**
 - a) to be aware that A.S.D. Trentina Karting enables the provision of food supply services to teams and companies using the facility "circuit" to carry out tests on the track, as it is a canteen activity of the company and that public access to the facility is not permitted at this time;
 - b) to be aware and to take note that A.S.D. Trentina Karting has complied with all legal requirements for the control and containment of the COVID-19 virus and undertakes to equip himself with personal protective instruments (mouth-nose protection and certified gloves). In recent weeks, no symptoms related to COVID-19 infection have been shown, such as body temperature above 37.5°C, cough, asthenia, myalgia, diarrhea, anosmia (loss of smell), ageusia (loss of taste). Not having been in contact with people affected by coronavirus (family members, workplace, etc.). To commit himself to complying with all legal requirements and the prescribed and/or oral rules mediated by the staff, to prevent the spread of contagion and the safe use of the facility, to commit himself in the various areas of the circuit, knowing that non-compliance will lead to immediate removal from the facility;
 - c) to allow the measurement of body temperature at each entrance of the sports facility for the purpose of preventing Covid-19 infection in order to ensure the implementation of anti-contagion safety protocols in accordance with article 1, n. 7, paragraph d, of the DPCM of 11th March 2020;
20. have indicated the correct personal data, knowing the criminal penalties provided for in the event of false statements, information and/or the use of false files, according to article 76 of the D.P.R. 445 of 28 December 2000;
21. to authorize the processing of personal data according to article 13 of the Legislative Decree 30 June 2003, nr. 196 'Code on the Protection of Personal Data' and Article 13 of the GDPR (EU Regulation 2016/679);
22. This declaration applies to all uses and entrances to the facility with the handing over of the card for multiple entries to the undersigned and shall apply until 31st December of the calendar year in which it was signed, except for updated and/or other written agreements. It is the obligation of the undersigned to notify and amend any changes to the above-mentioned personal data and/or documents and licenses and changes in their validity or effectiveness, which occur during the validity period of this statement, otherwise loses its validity with immediate effect and cannot be asserted, whereby A.S.D. Trentina Karting, the circuit and the Municipality of Ala shall be exempted from any liability or responsibility arising therefrom;
